Thank you for your recent Freedom of Information request about services for patients with complex mental ill health. Please find our response below, as requested we have not included information on patients with learning disabilities/ older people or units which specialise in care for people with an acquired brain injury.

Q1. Please provide, the number of beds of the following type which you have in your trust (please specify number according to bed type, ie. Complex care: x ; Community x; etc.):

1. Complex care **The Trust does not have Complex Care Beds**
2. Community **The Trust does not have Community Beds**
3. Long-stay **33**
4. High Dependency **The Trust does not have a High Dependency Unit**
5. 'Locked rehab' **The Trust does not have a High Dependency Unit**

Q2. For each of the above four bed types can you tell me the average daily cost of the following bed types:

1. Complex care **The Trust does not have Complex Care Beds**

Please note, we have used the national guidance on Out Of Area Placement's:

Out of Area Placement (OAP's) for acute mental health in-patient care is defined as happening when:

“A person with assessed acute mental health needs who requires adult mental health acute inpatient care, is admitted to a unit that does not form part of their usual local network of services. By this we mean an inpatient unit that does not usually admit people living in the catchment of the person’s local community mental health service, and where the person cannot be visited regularly by their care co-ordinator to ensure continuity of care and effective discharge planning”. This response is for “acute” mental health patients and not those in NHSE TIER 4 provision or complex placements.
